**WHEREAS**, the Township Clerk did duly advertise on February 11, 2010 to receive bids for said items; and

**WHEREAS**, in connection therewith the following five (5) bids were received by the Township of Ocean on March 10, 2010: Rehrig Pacific Company, Erie, PA, Toter, Inc., Statesville, NC, Mid Atlantic Waste Systems, Chester PA, Otto Environmental, Charlotte, NC and Bergey's Trucks, Inc., Pennsauken, NJ; and

**WHEREAS**, it was determined that the lowest responsive bidder meeting specifications for the bid was Bergey's Trucks, Inc., Pennsauken, NJ, d/b/a Bergey's Truck Center; and

**WHEREAS**, the Township Manager and the Superintendent of Public Works have recommended that a contract be awarded to Bergey's Trucks, Inc., Pennsauken, NJ, d/b/a Bergey's Truck Center at a cost not to exceed \$2,037,456.00; and
