

RESOLUTION

WHEREAS, the Township Council of the Township of Ocean authorized the Municipal Clerk to advertise for the receipt of bids for the Recapping of Tires, Accessories and Road Service on October 18, 2010; and

WHEREAS, the Township Clerk did duly advertise to receive bids for the recapping of tires, accessories and road service on October 30, 2010 and bids were opened on November 23, 2010; and

WHEREAS, in connection therewith, the following bidders submitted proposals for said service: Edwards Tire Co., Inc., Farmingdale, NJ, and Custom Bandag, Inc., Keyport, NJ; and

WHEREAS, the apparent low bidder, Custom Bandag, defaulted on the 2010 contract for same services and the Township of Ocean had no recourse but to terminate that contract in August 2010; and

WHEREAS, the Director of Public Works has reviewed said proposal and has recommended to the Township Manager that a contract be awarded to the second low bidder, Edwards Tire Co., Inc., Farmingdale, NJ as per their bid proposal for the recapping of tires, accessories and road service at a cost not to exceed \$48,813.75; and

WHEREAS, the Director of Finance has certified that sufficient funds will be made available by the Governing Body in the Township of Ocean Temporary and Final 2011 Municipal Budget for the purpose of award of this contract in the Public Works Budget – Maintenance of Equipment – Other Expenses, account #1-01-26-767-200;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Ocean, County of Monmouth that it does hereby authorize the award of a contract to Edwards Tire Co., Inc., Keyport, NJ for the recapping of tires, accessories and road service at a cost not to exceed \$48,813.75; and

BE IT FURTHER RESOLVED that the award of this contract is conditioned upon the delivery and execution of the appropriate insurance certificate, Affirmative Action Certificate and performance bonds as may be required by said specifications; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the following:
