SECTION II (For a complete explanation please refer to the ordinance 2099)

SKETCH: A sketch/survey showing the approximate location and size of all trees 9" or larger in diameter at breast height or greater that exist on the lot and identifying those trees to be removed.

For all lots that are 1/2 acre in area or less, all such trees shall be shown on the sketch.

For lots that exceed 1/2 acre in area, the sketch shall show all trees to be removed as well as all individual trees within 30' of any trees to be removed. Trees that are not within 30' of any tree to be removed shall be inventoried and shown on the plan as groupings of trees, with the number and size of trees indicated on the plan, but need not be individually shown on the plan.

If a tree is removed under the requirements of Section 9-2.4.3., a mitigation plan must be submitted which will provide for the replacement of all removed trees by planting a tree of 3" to 3 1/2" caliper or a contribution to the Township Shade Tree Fund in the amount of \$350.00 for each tree removed

**TREES TO BE REMOVED MUST BE CLEARLY MARKED IN THE FIELD
(i.e., colored tape around the tree or painted mark)**

Fees. Upon the filing of an application to the Construction Official for a Tree Removal Permit under the terms of this section, the applicant shall pay **an application fee of \$10.00 plus \$10 for each tree to be removed.**

Tree removal where a permit is not required under certain conditions:

1. Trees that are to be removed as the direct result of a development application that has been approved by the Township Planning Board or Zoning Board of Adjustment;
2. Any trees cut or removed in accordance with a "management plan" developed by the NJ DEP, Bureau of Forestry, filed with the Construction Official of Ocean Township;
3. Trees directed to be removed by, municipal, County, State or federal authority,
