IF A TREE IS REMOVED UNDER THE REQUIREMENTS OF SUBSECTION 9-2.4, PARAGRAPH a.2, a.3, OR a.4 ABOVE, A MITIGATION PLAN MUST BE SUBMITTED WHICH WILL PROVIDE FOR THE REPLACEMENT OF ALL REMOVED TREES, EXCEPT THOSE REMOVED UNDER PERMIT BY RIGHT, AS STIPULATED IN SUBSECTION 9-2.7, PARAGRAPH A. THE MITIGATION PLAN SHALL BE IN ACCORDANCE WITH THE FOLLOWING:

DECIDUOUS TREE: DBH 40" OR MORE	FIVE DECIDUOUS REPLACEMENT TREES	\$3,750
