## RESOLUTION APPOINTING MUNICIPAL PUBLIC DEFENDER AND AUTHORIZING PROFESSIONAL SERVICES AGREEMENT – RAYMOND RAYA, ESQ.

**WHEREAS,** the Township of Ocean, County of Monmouth (the "Township") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Township of Ocean requires the services of a municipal public defender; and

WHEREAS, the municipal public defender serves as defense attorney for all indigent persons accused of violations of the State, disorderly persons' act, motor vehicle statutes or any offense or charge which carries a potential penalty of a substantial fine, incarceration or a loss of driving privileges; and,

WHEREAS, at the discretion of the municipal court judge, and based upon the defendant's financial situation, the Court may appoint the municipal public defender to represent the individual's interests

WHEREAS, <u>N.J.S.A.</u> 2B:24-4 requires a municipal public defender to be an attorney-at-law of this State in good standing and shall serve for a term of one year from the date of his appointment and may continue to serve in office pending re-appointment or appointment of a successor; and

**WHEREAS,** the Township Manager of the Township of Ocean, County of Monmouth advertised for a Public Defender for the Township of Ocean; and

WHEREAS, one (1) proposal was received: Raymond Raya, Esq.; and

# AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER V OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF OCEAN, 1965" ENTITLED: LICENSES

**WHEREAS,** the Township of Ocean is a desirable location for the filming of motion pictures and television programs; and

**WHEREAS,** such filming has the potential to disrupt the peace and tranquility of the residents of Township of Ocean; and

**WHEREAS,** it is the desire of the Mayor and Council to minimize such disruptions by regulating such activities; now therefore

**BE IT ORDAINED**, by the Mayor and Council of the Township of Ocean, County of Monmouth, State of New Jersey, as follows:

## **SECTION I**

Chapter 5 "Licenses" of the "Revised General Ordinances of the Township of Ocean, 1965" shall be amended as follows; additions to the current ordinance are noted in underline.

# 5-19. FILMING

**5-19.1 Definitions.** As used in this section, these terms shall have the meanings indicated:

"Filming" shall mean all activity attendant to staging or shooting motion pictures, television shows or programs, commercial still photography, videotapes, computer-based programs or other visual reproduction technology now known or hereafter created. The period of filming includes the set-up, strike, time of photography and removal of all equipment.

"Private Property" shall mean any and all property that is not a public street, highway, sidewalk, square, public park or playground or any other public place within the Township of Ocean, but rather is owned by or assessed to a private person or entity.

"Public Lands" shall mean any and every public street, highway, sidewalk, square, public park or playground or any other public place within the Township which is within the jurisdiction and control of the Township of Ocean.

"Major Motion Picture" any film which is financed and/or distributed by a major motion picture studio, including but not limited to the following:

A. Universal Pictures.

B. Warner Brothers, including New Line Cinema, Castle Rock Cinema, Village Road Show and Bel-Aire.

- C. Paramount, including MTV Films and Nickelodeon Movie.
- D. 20th Century Fox, including Fox Searchlight.
- E. Sony/Columbia.
- F. Disney/Miramax.
- G. MGM/United Artists.
- H. Dreamworks.
- I. Any major streaming service, such as Netflix, Hulu, or Amazon Prime Video.
- J. Any film for which the budget is at least \$5,000,000.
- K. Recurrent weekly television series programming.

# 5-19.2 Permit required.

A. Except for filming exempted by Subsection B of this section, no person or organization shall film or permit filming on public lands within the Township of Ocean without first having made an application for a permit from the Township, which permit shall set forth the approved location of such filming and the approved duration of such filming by specific reference to day or dates.

B. The provisions of this chapter shall not be deemed to include the filming of news stories by recognized news gathering programs and organizations or the filming by an individual for personal and non-commercial use.

C. Permit must be readily available for inspection by Township officials at all times at the site of the filming, and a copy shall be transmitted to the Police and Fire Departments by the Township Manager or his designee. A copy of the permit shall be available to the public in the office of the Township Clerk during regular business hours.

D. If a permit is issued and due to inclement weather or other good cause filming does not take place on the dates specified, the Township Manager may, at the request of the applicant, issue a new permit for filming on the dates subject to full compliance with all other provisions of this chapter. No additional fee shall be paid for this permit.

E. Filming permits shall be valid from 7:00 a.m. until 10:00 p.m. on any day in which filming is authorized under the permit. Exemptions to film at other times shall be granted only upon a showing that night filming will not significantly disrupt the peace and quiet of residents in the vicinity of the filming.

# 5-19.3 Standards and procedures for granting permits.

A. All permits shall be applied for and obtained from the Township Manager or his designee during normal business hours. Applications for such permits shall be in a form

approved by the Township Manager or his designee and be accompanied by the applicable permit fee in the amount established in this Ordinance.

B. No permits shall be issued by the Township Manager unless applied for prior to four days before the requested shooting date; provided, however, that the Township Manager may waive the three-day period if, in his judgment, the applicant has obtained all related approvals and adjacent property owners or tenants do not need to be notified.

C. The Township Manager shall issue a permit under this chapter upon a determination following due investigation and consultation with such appropriate Township departments as are directly impacted by the application and are necessary from the nature of the application for review, that the applicant has complied with all other requirements contained in this chapter and the following criteria have been met:

- The proposed use will not unreasonably interfere with traffic or pedestrian movement, or unreasonably interfere with or endanger the public peace or rights of nearby residents to the quiet, peaceable enjoyment of property, or otherwise be detrimental to the public peace, health, safety or general welfare;
- 2. The proposed use will not unduly impede, obstruct or interfere with the operation of emergency vehicles or equipment in or through the permit area, or adversely affect the Township's ability to perform municipal functions or finish Township services in the vicinity of the permit area; and
- 3. The proposed use will not constitute a fire or safety hazard and all proper safety precautions will be taken as are reasonably necessary to protect the public peace, health, safety or general welfare.

D. If the applicant's production activity, by reason of location or otherwise, is likely to have a direct negative pecuniary effect on a business or merchant either by substantially limiting vehicular or pedestrian access to the business premises or if the production activity will directly and substantially interfere with a resident's use and quiet enjoyment of his or her property, such affected parties shall be given written notice of the proposed filming by the applicant contemporaneously with or prior to applying for a permit. This notice shall state that objections may be filed with the Township Clerk prior to a decision on the application and be considered during a review of the same. Applicants must demonstrate proof of service of notification to affected parties in conjunction with submission of an application. Failure to notify such parties is grounds for denial of a permit.

E. The Township Manager shall act upon the application in a timely fashion and shall approve or disapprove the application in a period of not greater than seven business days following the filing of the application. The applicant shall be immediately notified of the action of approval, denial or revocation of the permit application or permit issued under this chapter.

Notification may be by any means reasonably calculated to inform the applicant of the results of the determination.

F. The Township Manager may immediately revoke a permit that has been granted, if the conditions of the chapter and all applicable laws are no longer being met, or if the information supplied by the applicant becomes false and incomplete, or if any substantial change in circumstances results in the proposed use becoming detrimental to the public peace, health, safety or welfare. The Township Manager shall also have the right to revoke a permit if filming becomes detrimental to the public peace, health, safety or welfare.

G. If a permit is denied or revoked by the Township Manager, the notice of denial or revocation shall state the reasons for such action and the appropriate remedy or cure, if applicable. If a permit is denied or revoked by the Township Manager, the applicant has the right to appeal to the Mayor and Council of the Township of Ocean within 15 days of the date of the denial or revocation. Any appeal shall be submitted to the Township Clerk and heard by the Mayor and Council of the Township of Ocean within 45 days of the date of submission.

# 5-19.4 Insurance, indemnification and performance bond.

A. No permit shall be issued for filming upon public lands unless the applicant shall procure and maintain in full force and effect during the term of the permit a policy of insurance from an insurance company duly licensed to transact business under the insurance laws of New Jersey, which policy names the Township of Ocean, its officers, employees and agents as insureds or additional insureds under the policy. Sufficient proof of insurance shall be filed with the Township Manager prior to the issuance of any filming permit.

- 1. Insurance shall be maintained in the following minimum amounts:
- a. For bodily injury to any one person in the amount of at least \$500,000 and any occurrence in the aggregate amount of \$1,000,000.
- b. For property damage, each occurrence in the aggregate amount of at least \$500,000.
- 2. Additionally, workers' compensation insurance must be maintained in an amount at least equal to the statutory limits required by the State of New Jersey. The Township Manager or his/her designee may waive the requirement of insurance if the Township Manager determines that the intended use does not present any significant exposure to liability for the Township, its officers, employees or agents or to public property damage.

B. The applicant shall execute, in writing, an indemnification agreement substantially as follows:

"The applicant and any other persons, organizations, firms or corporations on whose behalf the application is made, represent, stipulate, contract and agree that they do jointly and severally defend, indemnify and hold harmless the Township of Ocean against liability for any and all claims for damage to property or injury to or death of persons including reasonable attorney fees and costs arising out of or resulting from the use of public lands and private property for the purpose of filming, including but not limited to the Township's issuance of a permit to film pursuant to this Ordinance."

C. The applicant shall post a security deposit in the form of a certified check in favor of the Township of Ocean in the amount of \$1,000. This deposit is to protect and ensure that the location utilized will be left after filming in an undamaged and satisfactory condition, free of debris, rubbish and equipment in accordance with all Township ordinances, laws and regulations. At the sole discretion of the Township Manger or his designee, the finance office will be provided a clearance certificate that the full security deposit is authorized to be returned. The Township will return the deposit if there has been no damage to public property or public expense caused by the filming at the next scheduled meeting of the Council after receipt of the clearance certificate and prior to the cut off for the bills list. If the Township Manager determines that such damage or public expense has been incurred, such funds as are necessary to make the Township whole shall be deducted from the deposit. The applicant may appeal such determination to the Mayor and Council of the Township of Ocean. Such appeal shall be heard within 45 days.

# 5-19.5 Standards for filming.

A. As a condition of any permit granted under this chapter, the applicant agrees to comply with all federal, state and local laws and regulations at all times, including but not limited to laws regarding public nudity, lewdness and public decency. Noise shall be limited in order to comply with Chapter 3-3 of the Code of the Township of Ocean.

B. Sufficient qualified security personnel shall be present whenever filming is to be conducted on public lands. Further, the Township reserves the right, as a condition of granting any permit under this chapter, to require one or more on-site patrolmen in situations where the proposed production will use live animals, firearms, explosives, pyrotechnics, police uniforms, police vehicles, or driving shots with tow or camera rigs or if the production may impede the proper flow of traffic. The cost to provide such patrolmen shall be borne by the applicant as a cost of production.

C. The holder of the permit shall take all reasonable steps to minimize interference with the free passage of pedestrians and traffic over public lands and shall comply with all lawful directives issued by the Ocean Township Police Department with respect thereto. An emergency lane must be kept open and available to police, fire and other emergency vehicles at all times, and there must be sufficient space available for public access at all times. The applicant shall work with the Police Department and Township Manager to prepare a written plan for providing emergency right-of-way for all vehicles.

D. The holder of a permit shall conduct filming in such a manner as to minimize the inconvenience or discomfort to adjoining property owners attributable to such filming and shall, to the extent practicable, abate noise and not park vehicles associated with such filming on public streets. The holder shall avoid any interference with previously scheduled activities upon public lands and limit, to the extent possible, any interference with normal public activity on such public lands.

E. The applicant shall permit the Ocean Township Fire Department or other Township officials to inspect the site and the equipment to be used at any time. The applicant shall comply with all safety instructions issued by the Fire Department or other Township officials.

F. The applicant shall maintain a qualified, licensed electrician on site if existing electrical lines are to be utilized by the production, unless it is determined by the Township Manager that due to the nature of the production it is not necessary to do so in order to protect the general public.

G. In addition to any other fees or costs mentioned in this chapter, the applicant shall reimburse the Township for any lost revenue that the Township was prevented from earning because of filming, such as parking meter revenue, or additional expenses incurred as a direct result of filming beyond the amount submitted as a security deposit. The applicant shall be informed of the estimated amount required to be paid under the terms of this provision at the time the permit is issued by the Township Manager. Upon completion of filming a final amount shall be determined by the Township, which shall promptly inform the applicant of the amount due. This amount shall be paid within five business days.

H. The applicant must provide sufficient pedestrian access. Local residents, business people and their customers must have access to and from their residences or businesses. If access is denied it will be considered a violation of this chapter.

I. The applicant must keep the location swept and free of debris at all times. All catering, craft service, construction debris and personal trash must be removed from the location each day at wrap and disposed of by private garbage disposal. The applicant may not use Township trash cans for production trash.

J. Production crew members are not permitted to block driveways without the express permission of the owner or lessee.

K. All signs erected by the applicant must be removed at the completion of filming.

# 5-19.6 Fees.

The schedule of fees for the issuance of permits authorized by this chapter is as follows:

A. Basic filming permit: \$200. Expedited permit \$250.

- B. Additional daily filming charge for use of public buildings, public parks or other public facilities:
- a. Daily filming fee payable in addition to the basic filming permit when filming on public property: \$300 per day
- b. Daily filming fee payable for major motion picture when filming on public property: \$1000 per day.

C. There shall be no charge for filming by a nonprofit organization, which qualifies under Section 501(c)(3) of the Internal Revenue Code as a charitable organization or is an accredited educational institution, and for which no person, directly or indirectly, shall receive a profit from the marketing and production of the film or from showing the films, tapes or photos.

D. There shall be no charge for filming exclusively on private property unless same interferes with the use of or causes congestion upon a Township roadway.

# 5-19.7 Violations and penalties.

Any person violating this chapter, upon conviction thereof, shall be punished by a fine not exceeding \$2,000 per offense or by imprisonment in the county jail for a term not exceeding 90 days. A separate offense shall be deemed committed on; each day during or on which a violation occurs or continues.

# 5-19.8 Applicability of other ordinances and regulations.

Nothing in this chapter shall be construed to impair or limit in any way any other power of the Township of Ocean to define and declare nuisances and to cause their removal or abatement. Nothing in this chapter shall be construed to abrogate or impair the power of the Township of Ocean or any officer or department to enforce any provisions of its charter or its ordinances or regulations, nor to prevent or punish violations thereof, and the powers conferred by this chapter shall be in addition and supplemental to the powers conferred upon the Township by any other law or ordinance.

# SECTION II

If any part of this Ordinance shall be deemed invalid such part shall be deemed severable and the invalidity thereof shall not affect the remaining part of this Ordinance.

# SECTION III

Any Ordinance or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed and superseded.

## SECTION IV

This Ordinance shall take effect upon final passage and publication in accordance with Law.

WHEREAS, 3200 Sunset Commons, LLC, in accordance with the provisions of N.J.S.A. 39:5A-1, submitted a request dated January 28, 2025, to request that Title 39 of the Revised Statutes be made applicable to Block 137, Lot 23 on the Tax Map of the Township of Ocean, more commonly known as 3200 Sunset Avenue.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Township of Ocean as follows:

## SECTION I

Chapter XII of the "Revised General Ordinances of the Township of Ocean, 1965" entitled: Traffic, is supplemented as follows:

## §12-15.4 3200 Sunset Avenue.

The driveways and parking lots as shown on a plan entitled "Preliminary and Final Site Plan" for 3200 Sunset Avenue, Block 137, Lot 23, on the tax maps of Ocean Township, dated 12/18/23, also known as 3200 Sunset Avenue, Township of Ocean, Monmouth County, NJ, being owned by 3200 Sunset Commons, LLC, shall be regulated and controlled by the provisions of Subtitle 1, Title 39 of the Revised Statutes of the State of New Jersey pursuant to and in accordance with the provisions of N.J.S.A. 39:5A-1.

### SECTION II

All signs, posts, striping or other necessary materials shall be installed and paid for by the property owner in accordance with the final approved plans and "as built" survey for the property. All signage shall conform to the current Manual on Uniform Traffic Control Devices, pursuant to N.J.S.A. 39:4-198 and N.J.S.A. 39:4-183.27, as well as any resolutions and approved site plans adopted by the Planning Board. The effect of this ordinance is contingent upon signs being erected by the property owner at its sole expense as required by law to the satisfaction of the Township of Ocean Police Department and the Township of Ocean Public Works Director.

This written request, pursuant to Section 1 of this act shall not be deemed to constitute a dedication to public use, of any such roads, streets, driveways, trails, terraces, bridle paths, parkways, parking areas, or other roadways open to or used by vehicular traffic, nor shall it be construed to prevent such persons, corporations or institutions, as owners of such property open to or used by the public for purposes of vehicular travel by permission of such persons, corporations or institutions and not as a matter of public right, from prohibiting such use or from requiring other or different or additional conditions than those specified in Subtitle 1, Title 39, of the Revised Statutes, or otherwise regulating such use as may seem best to such persons, corporations or institutions.

## SECTION III

All Ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed. If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subparagraph, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

#### **BOND ORDINANCE NO. 2514**

## BOND ORDINANCE PROVIDING FOR CAPITAL IMPROVEMENTS AND THE ACQUISITION OF VARIOUS CAPITAL VEHICLES AND EQUIPMENT, APPROPRIATING \$2,680,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$2,551,600 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE TOWNSHIP OF OCEAN, IN THE COUNTY OF MONMOUTH, NEW JERSEY

BE IT ORDAINED by the TOWNSHIP COUNCIL OF THE TOWNSHIP OF OCEAN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The improvements described in Section 3 of this bond ordinance are hereby authorized as general improvements to be undertaken in and by the Township of Ocean, in the County of Monmouth, New Jersey (the "Township"). For the improvements or purposes described in Section 3, there is hereby appropriated the sum of \$2,680,000, said sum being inclusive of all appropriations heretofore made therefor, including the sum of \$128,400 as the down payment for said purposes as required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq. The down payment is now available by virtue of provision for down payment or for capital improvement purposes in the Capital Improvement Fund of one or more previously adopted budgets.

Section 2. In order to finance the costs of said improvements or purposes not provided for by the application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount not to exceed \$2,551,600, pursuant to the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. (a) The improvements hereby authorized and the purposes for which the obligations are to be issued consist of:

i) acquisition of various information technology (IT) equipment, including, but not limited to, computers, monitors and a color printer/scanner, with a total appropriation and estimated cost of \$111,500, estimated maximum amount of bonds and notes therefor of \$106,150, and an average period of usefulness of 5.21 years;

ii) acquisition of vehicles and equipment for the Police Department, including, but not limited to, patrol sport utility vehicles (SUVs) and a radio amplifier system, with a total appropriation and estimated cost of \$375,000, estimated maximum amount of bonds and notes therefor of \$357,000, and an average period of usefulness of five (5) years;

iii) acquisition of vehicles for the Department of Human Resources/Recreation Department, including an SUV and a senior transportation van, with a total appropriation and

estimated cost of \$99,000, estimated maximum amount of bonds and notes therefor of \$94,250, and an average period of usefulness of five (5) years; and

iv) various acquisitions and improvements for the Department of Public Works (DPW), including, but not limited to, the acquisition of two (2) sanitation trucks, a loader with Rockland claw, a rear loader, a pickup truck with plow, a grain body truck with liftgate, a single axle dump hook truck and sanitation carts, and the refurbishment of a jet vac truck, with a total appropriation and estimated cost of \$2,094,500, estimated maximum amount of bonds and notes therefor of \$1,994,200, and an average period of usefulness of 10.62 years,

together with all purposes necessary, incidental or appurtenant thereto, all as shown on and in accordance with contracts, plans, specifications or requisitions therefor on file with or through the Township Clerk, as finally approved by the governing body of the Township.

(b) The estimated maximum amount of bonds or notes to be issued for the improvements or purposes described in Section 3(a) hereof is \$2,551,600, as stated in Section 2 hereof.

(c) The estimated cost of the improvements or purposes described in Section 3(a) hereof is \$2,680,000, which is equal to the amount of the appropriation herein made therefor. The excess of the appropriation of \$2,680,000 over the estimated maximum amount of bonds or notes to be issued therefor being the amount of said \$128,400 down payment for said purposes.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer of the Township, provided that no note shall mature later than one (1) year from its date. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer, who shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of such notes occurs, such report shall include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not a current expense and are improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

(b) The average period of usefulness of the improvements or purposes, within the limitations of the Local Bond Law and taking into consideration the amount of the

obligations authorized for said purposes, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is 9.40 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Township Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such Statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$2,551,600 and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$44,500 for interest on said obligations, costs of issuing said obligations, engineering costs, legal fees and other items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included as part of the cost of said improvements and is included in the estimated cost indicated herein for said improvements.

(e) To the extent that moneys of the Township are used to finance, on an interim basis, costs of said improvements or purposes, the Township reasonably expects such costs to be paid or reimbursed with the proceeds of obligations issued pursuant hereto.

Section 6. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Township Clerk and is available there for public inspection.

Section 7. Any grant or similar moneys from time to time received by the Township for the improvements or purposes described in Section 3 hereof, shall be applied either to direct payment of the cost of the improvements within the appropriation herein authorized or to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are received and so used.

Section 8. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and, unless paid from other sources, the Township shall be obligated to levy ad valorem taxes upon all the taxable property within the Township for the payment of the obligations and the interest thereon without limitation as to rate or amount.

Section 9. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
