A motion was made by Chairman Weinstein to approve the Minutes from the October 28, 2024, Planning Board hearing and was seconded by Vicechair DiFiglia. All were in favor.

Chairman Weinstein announced the review of Proposed Ordinance #2486, and Ordinance amending Chapter 21 of the Comprehensive Land Development, section 21-39A – CBO Cannabis Business Overlay zone, was voted on by the Council. Attorney Leckstein clarified this is a consistency review justifying it is consistent with the Master Plan. Member Mamiye motioned this conforms to the Master Plan, and Vicechair DiFiglia seconded. Chairman Weinstein asked if any members of the Public had any comments, and none were offered. He also asked the Board Members if they had any comments, and none were offered. As a result, Chairman Weinstein asked for a motion to adjourn, and Member Mamiye offered and Vicechair DiFiglia seconded.
